* A Relay event will be held in which all NOCs with athletes qualified in the three events (Men's Solo, Women's Solo and Mixed Double Sculls) will be invited to compete.

2. Maximum Number of Athletes per NOC:

The allocation and reallocation of quota places is in all cases subject to this maximum quota allocation per NOC.

3. Type of Allocation of Quota Places:

The quota places in all qualification regattas are allocated to the NOC(s) and the NOC may enter a boat with different athletes at the ANOC World Beach Games than those who qualified the boat.

For invitation places the quota places are allocated to the athlete(s). Hence, only the athletes that were selected by the Invitation Commission can compete for their NOC in the event for which the invitation place is allocated.

C. ATHLETE ELIGIBILITY

All athletes must comply with the following eligibility criteria (together, the **Athlete Eligibility Criteria**):

1. ANOC Eligibility Criteria

All athletes must respect and comply with the provisions of the [ANOC World Beach Games Regulations](#) (“AWBG Regulations”) currently in force, including but not limited to, Section IV, Rule 3 (Nationality of Competitors) and Section XI (World Anti-Doping Code and the Olympic Movement Code on the Prevention of Manipulation of Competitions).

Only those athletes who respect and comply with the AWBG Regulations, the World Anti-Doping Code and the Olympic Movement Code on the Prevention of Manipulation of Competitions, including the conditions of participation established by ANOC, plus the rules of the respective IF, may participate in the ANOC World Beach Games 2023.

Note: Section IV, Rule 1, of the AWBG Regulations provides that with regard to athlete eligibility in the case of conflict between the AWBG Regulations and the rules of the International Federation, the AWBG Regulations prevail.

2. Additional IF Eligibility Criteria:

To be eligible to participate in the ANOC World Beach Games 2023, all athletes, including those belonging to the Host Country or receiving Invitation Places, must adhere to the latest [World Rowing Statutes and Rules of Racing](#).

D. QUALIFICATION PATHWAY

The 2022 World Rowing Beach Sprints Finals, which has World Championship status, will serve as the global qualification opportunity for the 2023 ANOC World Beach Games. Additionally, Continental Qualification Regattas will ensure Continental representation. Where there is no Continental Qualification Regatta the two highest ranked boats per boat class from the respective continent at the 2022 World Rowing Beach Sprints Finals will qualify. For each event, the NOCs of the highest ranked boats will qualify according to the number of quota places indicated below:

The World Rowing Continental Qualification Regattas shall be held in accordance with the World Rowing Rules of Racing and the World Rowing Beach Sprint Rowing Regulations (Appendix R19). The progression system shall be the World Rowing Beach Sprint Progression System as shown on the World Rowing website. An NOC may enter only one (1) boat per event at the Continental Qualification Regatta and will be eligible for qualification only in the events in which their NOC has not already qualified through D.1.1 . |

The Invitation Places will be allocated to specific athletes within an eligible NOC.</p> <p>World Rowing and ANOC will contact eligible NOCs by 3 October 2022. Eligible NOCs shall reply to World Rowing and ANOC their interest by 30 November 2022. The Invitation Commission will confirm, in writing, the allocation of invitation places to the selected NOCs on 15 May 2023. The deadline for NOCs to accept the invitation is 29 May 2023.</p> <p>The allocation of invitation places is at the absolute discretion of the Invitation Commission provided the invited athletes comply with the eligibility criteria outlined in section C. If the Invitation Commission is not able to allocate an Invitation Place, it will be reallocated as per the procedure indicated in section F.</p> |

4. Relay Event Qualification:

Only NOCs, with boats competing in all three AWBG 2023 events (CM1x, CW1x and CMix2x) shall qualify for the Relay event. World Rowing decision on teams qualified to compete in the Relay shall be final.

The qualified NOCs will be confirmed by World Rowing during the first Team Leaders meeting the day before the Relay event. If any qualified NOC team declines or is not able to compete with all three boats in the relay, the quota place shall be left vacant.

E. CONFIRMATION PROCESS FOR QUOTA PLACES

World Rowing will publish the results on its website (www.worldrowing.com) following each qualification event and will inform the respective NOCs and Member Federations (MF) of their allocated quota places.

The NOCs will then have two (2) weeks to confirm in writing if they wish to use these quota places, as detailed in **section G**. If a confirmation is not provided by the deadline, the quota place obtained may be reallocated as per the procedure indicated in **section F**.

The quotas for the host country places and invitation places must be confirmed in writing with World Rowing by 29 May 2023.

F. REALLOCATION OF UNUSED QUOTA PLACES

1. Reallocation of unused Qualification Places:

If an allocated quota place is not confirmed by the NOC by the quota place confirmation deadline or is declined by the NOC, the quota place will be reallocated as follows:

- a) **2022 World Rowing Beach Sprint Finals:** If the NOC qualified through the 2022 World Rowing Beach Sprint Finals, as outlined in **section D, paragraph 1.1**, the quota place will be reallocated to the NOC of the next highest ranked boat, not yet qualified, in the respective event at the 2022 World Rowing Beach Sprint Finals, following the allocation of quotas in **D.1.1** and respecting the maximum number of athletes per NOC as specified in **section B, paragraph 2**.
- b) **Continental Qualification Regattas:** If the NOC qualified through the Continental Qualification Regatta, as outlined in **section D, paragraph 1.2**, the quota place will be reallocated to the next highest ranked eligible boat from the Continental Qualification Regatta. If there is no remaining eligible boat from that Continental Qualification Regatta (or no Continental Qualification Regatta has been held between 20 August 2022 and 14 May 2023), the quota place will be reallocated to the next highest ranked eligible boat from that continent from the 2022 World Rowing Beach Sprint Finals. If there are no other eligible boats from that continent, any remaining unused places from the Continental Qualification Regattas will then be reallocated to the NOC of the next highest ranked eligible boats, irrespective of continent, from the 2022 World Rowing Beach Sprint Finals.

2. Reallocation of unused Host Country Places:

If a quota place(s) obtained by the Host Country through the qualification pathways outlined in **section D, paragraph 1** or a quota place is not used by the Host Country, then the available Host Country quota place will be reallocated in the same manner as an unused quota place for that continent in **section F, paragraph 1.b**.

3. Reallocation of unused Host Country Places:

If the Invitation Commission is not able to allocate an invitation place or if a NOC declines an invitation place, then the invitation place will be reallocated in the same manner as an unused quota place in **section F, paragraph 1.a**.
