For information, the terms of office for the other MF elected positions on the ERB include Eva Szanto-HUN (2027), Asuncion Loriente-ESP (2028) and Morten Juel Hansen-DEN (2029)

b. Ratification of a World Rowing-nominated member to the European Rowing Board:

The positions of the World Rowing representatives on the European Rowing Board are currently held by Dušan Machacek (CZE), Jacomine Ravensbergen (NED) and Patrick Rombaut (BEL).

Dušan Machacek is the World Rowing Continental Representative for Europe and an ex-officio member of the European Rowing Board according to Art. 18.5.3 of the World Rowing Statutes.

The mandate of Jacomine Ravensbergen expires on Dec.31, 2028.

The mandate of Patrick Rombaut, reaching the 70-year age limit in 2026, ends Dec.31, 2026.

World Rowing will present in due time their nomination for ratification by the European Rowing Assembly.
